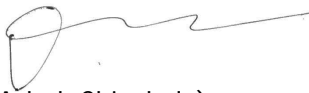

The Net Current Assets increased to Rs.252.73 lakhs as compared to increase to Rs.165.79 lakhs last year.

The Cash & Bank Balances stood at Rs. 109.04 lakhs.

LIQUIDITY

The liquidity of the Club funds has improved considerably on account of the increased Receipts under Entrance Fees and the Building Fund (Development Fees) coupled with lower outgo of capital expenditure. The net surplus of Rs.83.26 lakhs in the capital account registered an increase of Rs.80.54 lakhs over last year's net surplus. The cash and bank balances rose to Rs109.04 lakhs. registering an increase of Rs.98.28 over last year. This amount of Rs.109.04 lakhs excludes the deposit Rs.77.72 lakhs made with the Income Tax Department & Sales Tax department in connection with the Income Tax & Sales tax demand on the Club .

REVENUE ACCOUNT

Gross Income Increased by Rs.17.51 lakhs and stood at Rs.110.93 lakhs.

Gross Expenditure Increased by Rs19.75 lakhs and stood at Rs.107.26 lakhs.

**Net Revenue Surplus (before depreciation) stood at Rs.3.69 lakhs**

Net Deficit after Depreciation stood at Rs.18.85 lakhs as against last year's Rs.17.19 lakhs. Surplus from Operating A/cs. were the mainstay of Club's Income sources.

**REVENUE SURPLUS ACCOUNTS**

Kitchen sales topped all-time high at Rs.136.62 lakhs, and registered an increase by Rs.21.36 lakhs over last year. Kitchen surplus after staff salary and expenses stood at Rs.25.97 lakhs as compared to Rs.22.85 lakhs in the last year. The rate of return stood at 19%. The kitchen has shown improvement, However, in spite of increase in input cost there was no corresponding increase in billing amount of kitchen. We have endured to absorb the market variation and not to pass it on to our members.

Bar sales have marginally increased from Rs.74.45lakhs (last year) to Rs.83.01 lakhs during the year. Bar surplus stood at Rs.19.90 lakhs. ,

Guest Rooms surplus stood at Rs.18.94 lakhs.

**DEFICIT NET REVENUE ACCOUNTS**

The Deficit Revenue Account comprises Billiards, Entertainment Programmes A/c. Other Games A/c. T-Shirts/Ties A/c. and the Swimming Pool A/c.

This year also we have been able to present a good number of Entertainment programmes. However, this year we have been able to reduce the deficit on this a/c. to Rs. 0.71 as compared to Rs. 4.86 lakhs to previous year. As regards the shortfall in the Swimming Pool A/c. has emerged due to charging of salaries of staff attached to the Swimming Pool. Otherwise, the receipts and expenses (other than staff salaries) under Swimming Pool compared reasonably well with that of previous year.

5. Personal Accident Insurance Cover for eligible members and staff  
Arrangements were made during the year to provide group personal accident insurance cover to eligible members and staff of the Club upto Rs.2 lakhs each through the National Insurance Co. Ltd. The insurance warranty covers "death, permanent partial disablement, permanent total disablement, loss of limbs and loss eyes".
6. Club Track & Members Directory  
Publication of Club Track was published only once. The Members Directory is under preparation.
7. Country Club land  
The balance of payment of dues towards the land Govt. has been paid in full to the Government. The G.A.Dept had intimated the Club to take possession of the land which has been kept in abeyance for the time being.
8. Tax Demand Issues
  - a. Income Tax: The Club's Appeal under Section 253(3) of the Income Tax Act 1961 for the assessment year 1997-98 has been awarded in favour of the Club by the Honb'le Income Tax Appellate Tribunal upholding the claim of the Club as a Mutual entity. The Income Tax Dept. had further assessed the Club for assessment year 1998-99 which was appealed before the Commissioner of Income Tax (Appeals) and was also awarded in favour of the Club. Further for the Assessment year 2000-01 to 2004-05 have assessed with a sum of Rs.2.83 crores and against the said demand, a sum of Rs.37,21,633 has been held. The Club has filed an writ before the Honb'le Orissa High Court challenging the Income Tax demand. The said assessments are also an appeal before the Commissioner of Income tax (Appeals).
  - b. Service Tax: The Club has also preferred an appeal against the notices of Service Tax before the Hon'ble Orissa High Court.
  - c. Sales Tax: The Commercial Tax authorities have noticed the Club under the OST Act for assessment for the financial years 2000-01 to 2004-05 and had also assessed the club raising a demand of Rs.2.68 crores. The Assessment has been challenged before Honb'le Orissa High Court and as per directions of the Honb'le Court a sum of Rs. 33.50 lakhs was deposited with the Commercial Tax Department pending decision of the Hon'ble Court.
  - d. VAT: A demand was raised up to December 2005 by assessing a sum of Rs.2.00 cores. The club had filed writ before the Hon'ble Orissa High Court wherein we had challenged the basic issues about mutuality. The Hon'ble Orissa High Court had granted stay on demand and as per their order we have deposited a sum of Rs. 7.00 lakhs with the Commercial Tax Authorities.

14. Games & Sports

16. Library, Lounge, Gents Salon and Lawns  
Limited Library facilities have been provided in the Lounge Room with books purchased as well as the books received as donation from members. Newspapers and periodicals are regularly subscribed and made available in the Lounge for members' use. Beauty Salon services are provided for gentlemen with specified timings. The lush green lawns continued to be of the pride of the Club.

The Committee places on record their appreciation of the efforts put in by the employees of the Club at all levels. During the year, the salaries of the staff have been revised.  
The Club has no employee of the category specified under Section 217(2A) of the Companies Act, 1956.
19. Conservation of energy, Technology Absorption and Foreign Exchange Earnings and Outgo  
The Club, being a mutual concern involved with social, cultural and sports activities of members, has not consumed energy of any significant level and no additional investment was made for reduction of energy conservation. The Club was hit by a major lightning and had caused damage to electrical & computer gadgets to prevent recurrence lightning conductors were fixed and also to save energy, capacitor bank with new cabling and switch room have been installed. Reasonable economy measures were taken for energy saving/conservation. No comment is made on technology absorption considering the nature of activities of the Club. There has been no foreign exchange earning or outgo during the year.
20. Club Management – Meetings  
During the period under report, five formal meetings of Executive Committee were held in addition to the Annual General Meeting held on 8th July 2006. All the functional and matters of management were reviewed periodically. In addition, meetings of sub-committees and special meets/informal meetings of EC members and Invitees were held for smooth functioning of the Club.
21. Committee Members' Responsibility Statement  
Pursuant to Section 217(2AA) of the Companies Act, 1956, the Committee Members confirm that the Annual Accounts have been prepared in accordance with the applicable accounting standards. The management has selected such policies and applied them consistently and made judgements and estimates that are reasonable and prudent so as to give a true and fair view of the state of affairs of the club at the end of the financial year and profit/loss of the club for that period. Sufficient care has been taken for the maintenance of adequate accounting records in accordance with the provisions of the Companies Act, 1956 for safeguarding the assets of the Club and for preventing and detecting fraud and other irregularities. The annual accounts have been prepared on a going concern basis.
22. Statutory Auditors  
Messrs. H. Naik & Co. Chartered Accountants, the Statutory Auditors of the Club retire at the ensuing Annual General Meeting and are eligible for re-appointment.
23. Acknowledgement  
The Club management gratefully acknowledge the kind assistance and co-operation extended to the Club by the Government of Orissa, Banks, Auditors, Sponsors, affiliated clubs and other corporate bodies and organisations as well as the Members of the Club in the smooth functioning of the Club.
